1. This letter is furnished as a courtesy to you by the Municipal Court of San Saba County, Texas to assist you in making disposition of the charge(s) filed against you.

2. IF YOU FAIL TO RESPOND TO THE CHARGE(S) BY THE APPEARANCE DATE SHOWN ON THE CITATION, AN ADDITIONAL CHARGE WILL BE FILED AGAINST YOU FOR FAILURE TO APPEAR AND WARRANTS ISSUED FOR YOUR ARREST. A JUVENILE WHO FAILS TO APPEAR BY THE TIME AND DATE ON A CITATION MAY HAVE THEIR LICENSE SUSPENDED AS REQUIRED BY LAW (TRANSPORTATION CODE \*729.003). WARRANT FEES OF \$80.00 WILL BE ISSUED ON ALL CHARGES FOR EXECUTING OF PROCESSING WARRANT.

3. IF YOU WISH TO ENTER A PLEA OF GUILTY OR NOLO CONTENDERE, please so indicate below in the proper space provided, A plea of Nolo contendere means that you do not contest the state's charge(s) against you. The fine for a Nolo Contendere plea is the same as that for a plea of guilty. Either plea indicate that you agree to waive appearance before the court for trial.

4. Please refer to the schedule shown on the reverse side of this letter to determine the total amount of fine(s) and cost acceptable by the Court. Make your remittance by cashier's check or Money Order (CASH OR PERSONAL CHECK NOT ACCEPTABLE) payable to the Municipal Court marked at the top of this letter.

RETURN YOUR COPY OF THE CITATION AND THIS LETTER WITH YOUR REMITTANCE TO ASSURE PROPER CREDIT.

5. IF YOU WISH TO ENTER A PLEA OF NOT GUILTY and desire a trial, you must so indicate in the proper space provided below and mail to the Judge whose name is marked at the top of this letter no later than the appearance date shown on the citation. You shall be notified by return mail of the court date set. You have the right to either a JURY OR NON JURY trial. Please indicate your choice. JURY or NON JURY.

Under the laws of the State of Texas, you may be able to have one charge be dismissed by taking a driving safety course. HOWEVER, YOU WILL LOSE THAT RIGHT IF YOU DO NOT PROVIDE WRITTEN NOTICE TO THE COURT YOUR DESIRE TO DO SO ON OR BEFORE THE APPEARANCE DATE SHOWN ON YOUR CITATION. (You cannot have a speeding citation dismissed if it is a violation 25 MPH or more above the posted limit. You are ineligible if you have used this option (CCP-ARTICLRS 45.0511(b)(1) during the year proceeding the date of the citation. You are not eligible if you hold a CDL. You must have a valid Texas Drivers License, must show proof of insurance and send your written notice by certified mail with a return receipt requested.

DO NOT MAIL CASH OR PERSONAL CHECKS- REMIT CASHIER'S CHECK OR MONEY ORDER  
JUVENILES 16 & UNDER MUST CONTACT COURT WITH PARENT OR GUARDIAN

A PARENT must accompany a MINOR under 17 years of age to COURT before a PLEA can be accepted from the Minor when charged with A TRAFFIC, ALCOHOL, SCHOOL OR TOBACCO offense.

IF A WARRANT OR CAPIAS IS ISSUED- ADDITIONAL FEES WILL BE ASSESSED

A written request to take a course MUST be sent to the Court by Certified Mail, Return Receipt Requested post marked on or before the answer date on the notice to appear. If you come in person, you MUST submit a written request to take a course and it MUST be dated on or before the answer date on the notice to appear.

**DRIVING SAFETY COURSE REQUEST FORM (D.S.C.)**

FAILURE TO MEET ALL REQUIREMENT CAN RESULT IN YOU NOT BEING GRANTED A D.S.C.

I hereby plead (guilty)(no contest)to the offense, a \_\_\_\_\_, as stated on the attached citation, and waive a trial by jury. I certify that: \* I have a valid Texas Driver's License.

\* I have not taken a driving safety course to obtain dismissal of a ticket within one year proceeding the date of this ticket. \* I am not charged with speeding 25 MPH or more over the posted speed limit.

\* I do not have a Commercial Drivers License (CDL).

I have attached proof of financial responsibility (liability insurance) as required by Section 1A, Texas Motor Vehicle Safety Responsibility Act. I understand that the Court will enter a judgement against me for a fine and cost totaling \$\_\_\_\_\_ and will defer the imposition of the judgement for 90 days to allow me to take the driving safety course and furnish proof of successful completion of a driving safety course approved under the Texas Driver and Traffic Safety Education Act., and a copy of your Texas Drivers License Record. Then the court will remove the judgement and dismiss the charge or I will be required to pay the fine and cost. I also understand that the Court may issue a capias pro fine.

Stating the amount of the judgement and sentence which may result in my being arrested and brought before the Court.

**DEFENDANT'S ACKNOWLEDGMENT**

I, the Defendant understand that on a plea of (guilty)(no contest), the court will enter judgement against me assessing \_\_\_\_\_ a fine in the amount of \$\_\_\_\_\_. I also understand that I am required to present a uniform certificate of completion of the driving safety course on or before \_\_\_\_\_. I hereby give my promise to complete the course and furnish the proof as required. I understand that if I fail to furnish the required evidence of the driving safety course within the 90 day period specified, the Court will require me to appear at the time and place specified in a \_\_\_\_\_ notice to me at the address appearing on the citation, to show cause why I have not presented evidence of completion \_\_\_\_\_ of the driving safety course. I understand that my failure to appear at the time and place stated in that notice shall constitute and offense punishable by a fine of not more than \$200.00. If I fail to appear, in addition, the court \_\_\_\_\_ may issue capias pro fine stating the amount of his judgement and commanding the sheriff or constable to bring me \_\_\_\_\_ before the Court I further understand that I must enclose \$109.00 court cost with this request and that the fee \_\_\_\_\_ court cost are non-refundable even if for any reason I later do not take the driving safety course.
